Coalition / Network Partnerships

- 1. **MassQuito Coalition-** Drafted legislation, secured sponsors, and submitted legislation to implement Task Force recommendations to modernize the state mosquito control program.
- 2. **Save White Pond-** filed legal action to stop the destruction of the wetlands; joined group with a larger local coalition.
- 3. Akron Environmental Justice Coalition- held a candidates' forum on the environment for City Council and Mayor candidates Spring 2023. Held six public listening sessions across community gathering citizen input on the environment. Held Riparian Set-back City proposed ordinance public meeting. Feb. 2023- sign on letter with American Bird Conservancy, a Petition asking EPA OPP to amend its regulation so it will apply to future registrations (and re-registrations) of all neonicotinoids and other systemic insecticides in order to require careful analysis showing the benefits of the proposed products actually exceed their costs, including to society and to the environment.
