# **Coalition / Network Partnerships**

- 1. **MassQuito Coalition-** Revised previous year, secured sponsors, and submitted legislation to implement Task Force recommendations to modernize the state mosquito control program.
- 2. Akron Environmental Justice Coalition- held public forum with 100+ community and City staff seeking community input for sustainability, Inner Belt restoration, etc., monitored City Sustainability Office activities; begin education of plastics recycling plant pollution in East Akron; collaborated with National Park Service to facilitate their traveling display of 50 years of the CVNP.

## **Consulting Services:**

 Assess Northeast Ohio music outreach nonprofit whose founder had retired. Collaborate on programs with other nonprofits for services to K-12 students, families in music deserts, and residents of senior housing and memory care facilities. Create policies, procedures, assessed operations, reduced expenses by 26%, create job descriptions, hire Education Program Director; re-brand organization with consistent marketing design; upgrade annual benefit; address organization's Black Lives Matter support; meet with all stakeholders (funders, contractors, Board, vendors), set-up 25 year old organization's first CRMcustomize it for program services provided, create operations processes with staff, secure \$300K in grants in eight months.

- National Pollution Discharge Elimination System (NPDES) Draft 2026 Pesticide General Permit (Docket ID Number EPA–HQ–OW–2023–0268), sign-on with NOFA-MASS, and MASS Rivers Alliance.
- 2. Comments on the Endangered Species Act Draft Rodenticide Biological Evaluation (EPA-HQ-OPP-2023-0567-0004) sign-on with Center for Biological Diversity
